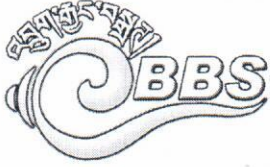

1. All the bids must be submitted in a **sealed envelope** marked as “**Quotation for Air Ticket**” to the Manager, Administration and Finance Department, BBSC latest by **June 28, 2018** before **11:00AM**
2. The rate should be quoted as per the sectors as mentioned above and will be selected for the **most economical route.**
3. Airline must be confirmed while submitting the quotation.
4. The validation of the fares and availability of seats should be as per the details mentioned above.
5. The successful bidders should submit photocopy of every tickets along with their invoices for payment.
6. Unconditional quotations like an increase of fares or changes of airlines at time of travel are not accepted.
7. Tender documents should be accompanied by a photocopy of **valid trade license, tax clearance certificate** issued by respective authority.
8. Tender should be accompanied with lump-sum amount of **Nu. 5000/-** only as bid security in the form of draft/cash warrant issued in favour of Managing Director, BBSC. **Those issuing personal / company cheques will be rejected.**
