- 1. The Bhutan Broadcasting Service Corporation Limited now invites sealed Bids from eligible and qualified Bidders for the Re-tender of the Supply, Installation, Testing & Commissioning of Broadcast Equipment for BBSCL Television.
- 2. Bidding will be conducted through the national and International Competitive Bidding procedures specified in the RGoB Procurement Rules and Regulations, and are open to all Bidders from Countries as defined in Section V of the Bidding Documents.

- 4. Qualification requirements include: As specified in the tender document.
- 5. A complete set of Bidding Documents in English may be purchased by interested Bidders upon payment of a non-refundable fee of Ngultrum/ Rupees 2000.00 or in equivalent foreign currency. The method of payment will be either on cash or direct deposit to the specified account number; [100891832] (Bank of Bhutan (BOB)). For direct deposit, transaction receipt must be submitted for verification and issuance of BBSC cash receipt. - 6. Bids must be delivered to the address below at or before 4<sup>th</sup> January, 2023 at 10:30AM <u>Bhutan Time</u>. Electronic bidding shall be permitted. Late Bids will be rejected. Bids will be opened physically and electronically in the presence of the Bidders' representatives who choose to attend in person or on-line at the address below on 4<sup>th</sup> January, 2023 at 11:30AM <u>Bhutan Time</u>.

All Bids shall be accompanied by a Bid Security of [2% of Bid Price] in the form of Unconditional Guarantee/Banker's Cheque/Cash Warrant/Demand Draft issued by a reputed Financial Institution in Bhutan acceptable to the procuring agency. If the institution issuing those instruments is located outside Bhutan, it shall have a correspondent financial institution located in Bhutan to make the financial instrument enforceable.
