- 3. The airline must be confirmed while submitting the quotation.
- 4. The validation of the fares and availability of seats should be as per the details mentioned above.
- 5. The successful bidders should submit a photocopy of every ticket along with their invoices for payment.
- 6. Unconditional quotations like an increase in fares or changes of airlines at the time of travel are not accepted.
- 1. The tender documents should enclose a photocopy of a valid trade license, and tax clearance certificate issued by the respective authority.
- 7. The bidder should submit a lump-sum amount of **Nu. 5,000/-** only as bid security in the form of draft/cash warrant in favour of BBSCL, Chubachu, Thimphu.
