Terms and conditions

1. All the bids must be in a **sealed envelope** marked as “**Quotation for issuance of the Air Ticket**” addressed to the Manager, Corporate services Department, BBSCCL latest by **31st March 2026 before 10.30 AM and open on the same day at 11.00 AM.**
2. The rate should be quoted as per the sectors mentioned above and will be selected for the **most economical route.**
3. The airline must be confirmed while submitting the quotation.
4. The validation of the fares and availability of seats should be as per the details mentioned above.
5. The successful bidders should submit a photocopy of every ticket along with their invoices for payment.
6. Unconditional quotations like an increase in fares or changes of airlines at the time of travel are not accepted.
1. The tender documents should enclose a photocopy of a **valid trade license, and tax clearance certificate** issued by the respective authority.
7. The bidder should submit a lump-sum amount of **Nu. 5,000/-** only as bid security in the form of draft/cash warrant in favour of BBSCCL, Chubachu, Thimphu.
8. The bid security of **Nu.5,000/-** of the lowest evaluated bidder shall be retained with an organization as performance security and will return only after the issuance of air tickets.
9. Quotation without bid security and sealed envelope will be rejected.
